EVENT FORMAT	<i>Two qualifying divisions - Boys Scratch, Girls Scratch. Bowlers will bowl a 6-game qualifying block across 12 lanes. Top 40% (plus ties) in each division will advance to Advancers Round. Advancers will bowl two additional games. The top 8 bowlers will then advance to a modified eliminator championship round. Ties for 8th, 4th, and 2nd will be decided by a 9th/10th frame rolloff. All ties during eliminator round decided by one ball roll off.</i>		
PROJECTED PAYOUTS (entry fee only)	<u>Based on 25 Bowlers per Division</u> 1st \$250, 2nd \$175, 3rd \$150, 4th \$125 5th \$100 <i>Scholarships awarded using a 1:5 ratio</i>	<i>Additional monies from event sponsors and/or 50/50 or merchandise raffles will be split into event fund and year end fund.</i>	
RULES	<p>All NWIJTPA rules will apply. If not specifically covered by NWIJTPA rules, USBC rules will be applied. NWIJTPA dress code will be enforced (dress slacks, collared shirt, no head wear, Ladies may wear skorts/skirts) Must be USBC certified youth member to participate. Junior Gold Qualifier - advancement ratio will be atleast 1:8. Cost to enter qualifier is \$25. Standings based on 5-game qualifying block. Qualifier open to both NWIJTPA members and non-members. If tie occurs for final JG advancing spot, a 1-game rolloff will take place. If still tied, a 9th-10th frame rolloff will occur. NWIJTPA members will have priority to event spots until deadline, then spots will be filled on first paid basis. Bowler of the Year points will be awarded to participating members only based on NWIJTPA rules.</p>
