EVENT FORMAT	<p>There are two divisions: Boys Scratch, Girls Scratch. Bowlers will bowl a 6-game qualifying block across 12 lanes Top 8 then advance to modified eliminator bracket format. Seeds 5-8 bowl 1 game, high 2 scores advance and are joined by seeds 3 & 4. Top 2 then advance and are joined by seeds 1 & 2. Top two then advance to bowl for title. All eliminator round matches are single game matches. All Eliminator round ties, broken by one ball roll off. Tie for 8th position uses 9/10th frame format</p>	<p>Junior Gold Qualifier \$25 atleast 1:8 advancement ratio Separate divisions for U12B, U12G, U15B, U15G U20B, U20G if sufficient entries exist</p>

RULES	<p>All NWIJTPA rules will apply. If not specifically covered by NWIJTPA rules, USBC rules will be applied. NWIJTPA dress code will be enforced (dress slacks, collared shirt, no head wear, Ladies may wear skorts/skirts) Must be USBC certified youth member to participate. Junior Gold Qualifier - advancement ratio will be atleast 1:8. Cost to enter qualifier is \$25. Standings based on 6-game qualifying block. Qualifier open to both NWIJTPA members and non-members. If tie occurs for final JG advancing spot, a 1-game rolloff will take place. If still tied, a 9th-10th frame rolloff will occur.</p> <p>NWIJTPA members will have priority to event spots until deadline, then spots will be filled on first paid basis. Bowler of the Year points will be awarded to participating members only based on NWIJTPA rules.</p>
