<b>EVENT FORMAT</b>	Two qualifying divisions - Boys Scratch, Girls Scratch. Qualifying - 6 Games across 12 lanes. Top 8 boys and Top 8 girls advance to Semi Finals. Semi finals will consist of two 4-person brackets. Each bracket will be double-elimination format with single game matches to determine advancer to Championship Round. Championship round will be 2-game total pin match. Position ties will be based on highest 6th game, then 5th, etc.. If a tie exists during match play rounds, a 1-ball roll-off will be used until advancer is determined. if tie exists for 8th following qualifying, 9th-10th frame rolloff used.

<b>RULES</b>	All NWIJTPA rules will apply. If not specifically covered by NWIJTPA rules, USBC rules will be applied. NWIJTPA dress code will be enforced (dress slacks, collared shirt, no head wear, Ladies may wear skorts/skirts) Must be USBC certified youth member to participate. Junior Gold Qualifier - advancement ratio will be atleast 1:8. Cost to enter qualifier is \$25. Standings based on 6-game qualifying block. Qualifier open to both NWIJTPA members and non-members. If tie occurs for final JG advancing spot, a 1-game rolloff will take place. If still tied, a 9th-10th frame rolloff will occur.  NWIJTPA members will have priority to event spots until deadline, then spots will be filled on first paid basis.
