EVENT FORMAT	<p>There are two divisions: Boys Scratch, Girls Scratch. Bowlers will bowl a 6-game qualifying block across 12 lanes Top 2 advance to championship round. Seeds 3-12 to advancers round. Advancers Rnd is 2 games. Top 4 based on 8 game total to championship rnd. Championship Round will be a seeded bracket. Seeds 1 & 2 earn first round bye. All Championship round matches are 2-game total pin matches. Ties for 2nd or 12th following qualifying decided by 9th-10th frame rolloff. Tie for 6th following advancers round decided by 9th-10th frame rolloff. All Championship round ties broken by one ball rolloff. All positional ties for seeding based on event high game.</p>	<p>Junior Gold Qualifer \$25 atleast 1:8 advancement ratio Separate divisions for U12B, U12G, U15B, U15G U20B, U20G if sufficient entries exist</p>

RULES	<p>All NWIJTPA rules will apply. If not specifically covered by NWIJTPA rules, USBC rules will be applied. NWIJTPA dress code will be enforced (dress slacks, collared shirt, no head wear, Ladies may wear skorts/skirts) Must be USBC certified youth member to participate. Junior Gold Qualifier - advancement ratio will be atleast 1:8. Cost to enter qualifier is \$25. Standings based on 6-game qualifying block. Qualifier open to both NWIJTPA members and non-members. If tie occurs for final JG advancing spot, a 1-game rolloff will take place. If still tied, a 9th-10th frame rolloff will occur. NWIJTPA members will have priority to event spots until deadline, then spots will be filled on first paid basis. Bowler of the Year points will be awarded to participating members only based on NWIJTPA rules.</p>
