<b>EVENT FORMAT</b>	<i>There are two divisions: Boys Scratch, Girls Scratch.</i>  <i>Saturday Qualifying - 8 games on two patterns (Pattern "A" for games 1-4, Pattern "B" for games 5-8). Cut to top 8 players in each division.</i> <i>Sunday Finals - 8 games of round robin match play with bonus pins.</i> <i>Top 3 players based on 16 game including bonus pinfall, advance to stepladder finals. Stepladder matches are 2-game total pinfall.</i>	<b>Junior Gold Qualifier \$25</b> <b>atleast 1:8</b> <b>advancement ratio</b> <b>Separate divisions for U15B,</b> <b>U15G</b> <b>U20B, U20G</b> <b>if sufficient entries exist</b>

<b>PROJECTED PAYOUTS</b>	<b><u>Based on 25 Bowlers per Division</u></b> <b>1st \$400 - 2nd \$300 - 3rd \$200 - 4th \$150 - 5th \$125</b> <i>Scholarships awarded using a 1:5 ratio</i>	<i>Additional monies from event sponsors and/or 50/50 or merchandise raffles will be split into event fund and year end fund.</i>

<b>RULES</b>	All NWIJTPA rules will apply. If not specifically covered by NWIJTPA rules, USBC rules will be applied. NWIJTPA dress code will be enforced (dress slacks, collared shirt, no head wear, Ladies may wear skorts/skirts) Must be USBC certified youth member to participate. Junior Gold Qualifier - advancement ratio will be atleast 1:8. Cost to enter qualifier is \$25. Standings based on 8-game qualifying block. Qualifier open to both NWIJTPA members and non-members. If tie occurs for final JG advancing spot, a 1-game rolloff will take place. If still tied, a 9th-10th frame rolloff will occur.  NWIJTPA members will have priority to event spots until deadline, then spots will be filled on first paid basis. Bowler of the Year points will be awarded to participating members only based on NWIJTPA rules.
