<b>EVENT FORMAT</b>	<p><i>There are two divisions: Male-Male Scratch, Female-Female Scratch.</i></p> <p><i>Bowlers will bowl a 6-game qualifying block across 12 lanes - 12 game team total determines advancers. Top 8 advance to match-play bracket. Bracket matches are best 2 of 3 baker format. Youth bowler must be anchor during baker matchplay..</i></p>

<b>RULES</b>	<p>All NWIJTPA rules will apply. If not specifically covered by NWIJTPA rules, USBC rules will be applied.</p> <p>NWIJTPA dress code will be enforced (dress slacks, collared shirt, no head wear, Ladies may wear skorts/skirts)</p> <p>Must be USBC certified youth member to participate. NWIJTPA Gold Members must also be USBC JG members. Junior Gold spots awarded to NWIJTPA GOLD members only (1 in 4 ratio) based on 6-game total PINFALL. There will be no more than 4 bowlers to a lane. NWIJTPA members will have first priority until deadline, then spots will be filled on first paid basis. If tie occurs for final JG spot, 1 game roll-off will determine advancer. If still tied, 9th-10th frame roll-off will be used until advancer is determined.</p> <p>Bowler of the Year points will be awarded to participating members only based on NWIJTPA rules.</p>
