#### **EVENT FORMAT**

Two qualifying divisions - Boys Scratch, Girls Scratch.

Qualifying - 6 Games across 12 lanes. Top 8 boys and Top 8 girls advance to championship round.

Seeds 1,4,5,8 in Pool A, Seeds 2,3,6,7 in Pool B. Double Elimination within Pool. Winners of each Pool then bowl 1 game for title. If tie exists following qualifying, higher seed will be based on highest 6th game,

then bowl 1 game for title. If tie exists following qualifying, higher seed will be based on highest 6th game then 5th, etc.. Exception, tie for 8th is decided by 9/10th frame rolloff. If a tie exists during championship round, a 1-ball roll-off will be used until winner is determined.

# PROJECTED PAYOUTS (entry fee only)

#### <u>Based on 25 Bowlers per Division</u> 1st \$275, 2nd \$225, 3rd \$175, 4th \$125, 5th \$100

Scholarships awarded using a 1:5 ratio DTOUR - 1st \$200, 2nd \$125, 3rd \$75

Additional monies from event sponsers and/or 50/50 or merchandise raffles will be split into event fund and year end fund.

#### **RULES**

All NWIJTPA rules will apply. If not specifically covered by NWIJTPA rules, USBC rules will be applied. NWIJTPA dress code will be enforced (dress slacks, dress shorts collared shirt, no head wear, Ladies may wear skorts/skirts)

Must be USBC certified youth member to participate.

Junior Gold Qualifier - advancement ratio will be atleast 1:8. Cost to enter qualifier is \$25. Standings based on 6-game qualifying block. Qualifier open to both NWIJTPA members and non-members. If tie occurs for final JG advancing spot, a 1-game rolloff will take place. If still tied, a 9th-10th frame rolloff will occur.

NWIJTPA members will have priority to event spots until deadline, then spots will be filled on first paid basis.
