There will be no more than 3 bowlers to a lane. Only NWIJTPA members meeting the eligibility requirements will be allowed to participate.</p> <p>Patterns will be selected prior to event. Patterns will be short, medium, long with atleast two from WTBA library. Stepladder finals pattern will be choice of top seed. Top seed may choose between fresh short, fresh medium, fresh long, or current (no re-oil). Practice pairs will be oiled as well, if necessary.</p>
